## RIDER INFORMATION:

**This is MOMCC's ability-based racing event. We're giving mini and junior riders the opportunity to face-off on the track based on skill and ability, casting aside the constraints of traditional age-based class options (*Minimum age / cc rating rules apply as per MNZ*).**

- 7-8 Yrs MX50cc riders can race in the 7-8 Yrs 65cc class
- 8 Yrs 65cc riders can race in the 8-11 Yrs 85 class
- 12-16 Yrs 85cc 2-str or 150cc 4-str can ride in the 125cc class
- 14-16 Yrs can ride a 125cc in the 250cc class

***For all entries, minimum age / cc rating rules apply as per rule 15.8***

Venue: Flipp MX Park, Omanuka Road, Foxton  
Sign In: Sign In 7.00am – 8.00am  
Riders Briefing: 8.15am by the sign in caravan  
Practice: 8.30am.  
Noise testing: May take place (Noise limit 98db).  
Prizes: Trophies 1<sup>st</sup> - 3<sup>rd</sup> for mini classes  
Trophies 1<sup>st</sup> - 3<sup>rd</sup> for Junior classes.  
Sponsor Spot Prizes – Competitors must be present to receive a spot prize.

Points:	As per MNZ (Off-Road Manual, 6.14a) points will be awarded 1st – 20th placing as follows: 25, 22, 20, 18, 16, 15, 14, 13, 12, 11, 10, 9, 8, 7, 6, 5, 4, 3, 2, 1.
Prize Giving:	Held at the track, approx. 30 mins after last race.
Classes:	Subject to entries received and may be changed The Organisers reserve the right to alter race durations to ensure meeting remains on schedule.
Entry Fee:	\$65.00 (includes transponder hire) Double Class Fee \$30.00 Day Licence \$35.00
Late Entries:	Will be accepted at the Organiser's discretion. Late entry fee \$20.00. No entries will be accepted on the day. All entries will be accepted unless you are notified otherwise. Maximum of 30 riders per class
Riders Briefing:	All competitors must attend riders briefing as per rule 6.4.
Riders Rep:	To be appointed at riders briefing.
Track/Pit Rules:	Pit bikes are not permitted at this event.
Alcohol:	The use of alcohol is not permitted as per rule 6.20.
Catering:	Food will be available to purchase at the event.
Force Majeure:	For reasons of Force Majeure, should a meeting or part of a meeting be cancelled any refund of the entry fee will be made at the sole discretion of the Organisers. The Organisers reserve the right to alter the meeting format as deemed necessary.

- 4. I am aware that the sport of Motorcycle Competition might a) cause me injury; serious or otherwise b) damage my property.*
- 5. I wish to take part in the MOMCC Club Champs 2023 Round Two despite the above risks.*
